



## Warranty Registration

### Manufacturer's Limited Warranty

Playfield USA, LLC warrants that if Playfield synthetic turf product \_\_\_\_\_ proves to be defective in material or workmanship, resulting in premature wear for a period of 8 years or degradation from ultra violet radiation from the sun or the turf fibers losing more than 50% of their pile height, within 8 years from the date of completion of installation, during normal and ordinary use of the product, Playfield will, at Playfield's option, either repair or replace the affected area without charge (but no cash refunds will be made). This warranty does not come into effect until this certificate is completed and sent for validation to the head office of Playfield indicated below within 30 days of installation. Customer agrees to all terms of Playfield USA warranty listed on Playfield USA website at [www.playfieldusa.com](http://www.playfieldusa.com). Playfield USA will mail or fax a copy of the full warranty on request.

### Exclusions

This limited warranty *does not cover*:

1. Damage resulting from accident, force of nature, misuse, abuse, and neglect or from any other than normal and ordinary use of the Product.
2. Damage arising from turf fibers being pulled up from their original pile height by the twisting action of athletic shoe soles is considered normal use and is not covered by the warranty.
3. Damage resulting from failure to maintain the Product by not cleaning animal wastes or other waste materials off of it; damage from not sweeping and/or power brushing product at least quarterly or damage done by customer during this process; damage caused by improper removal or non-removal of blown in dirt, leaves or other damaging materials.
4. Damage resulting from repair or attempted repair by anyone other than Playfield or an authorized distributor or authorized third party serviceman.

*We disclaim liability for incidental and consequential damages for breach of any express or implied warranty, including any implied warranty or merchantability, with respect to the Product.*

*In the event that the Product is used for purposes other than the specific activities set out below or any other uses for which Playfield gives its written authorization, it being understood that Playfield has tested the Product for use in connection with these sporting activities and may not have tested it for other uses, Playfield shall not be responsible for any and all damages incurred and this limited warranty as well as all legal warranties shall become null and void.*
